## **Region 5 Caller, Cuer, Dancer Association**

2020/2021 Status Report in Lieu of AGM (cancelled due to Covid 19 Pandemic)

The AGM is usually held in conjunction with a Region 5 dance event but all dancing in our region has been cancelled until further notice due to health regulations created as a result of the Covid 19 crisis. We lost the 20/21 dance season completely.

As president of the region, I have compiled this document as a means of passing on information to the Region 5 members in lieu of the 20/21 AGM .

**1. Minutes of previous meeting** - There was no AGM in 2020 due to the Covid health crisis. Instead, the president prepared an AGM Region Report. This was posted on the Region 5 website. 2. Business Arising from Minutes of May 2020 Report - none. No one in the Region made any comments or any requests.

### 3. Correspondence

The correspondence received was primarily to announce the cancellation of many dance events due to the Covid 19 situation. Other correspondence was to inform us of BCS&RDF meetings to be held using Zoom technology. All this information was passed on to the members in emails, bulletins and posted on the R5CCDA website.

# 4. Reports & Business Arising from Reports

A. Although the dance activity was cancelled for the season, the executive members of the BCS&RDF continued to work for us. They held meetings and posted their reports on the Federation website. We thank our Directors-at-Large, Bill and Jan Cave who represented us at the 2020/2021 BCS&RDF meetings. The meetings were held online using a program called Zoom. The results of the meetings were posted on the R5CCDA website in the form of bulletins and on the BCS&RDF website.

It has been approved as a destination program for those clubs or areas that wish to try it as a means to increase the numbers of dancers.

It also announced the sudden resignation of the BCS&RDF president, Jean Wood. The acting president is now Dennis Sutton.

### B. Treasurer's Report - prepared by Jordi Guri

- •As mentioned previously, the financial statements will no longer be published on the website due to scammers and crooks. Had we had the meeting in person, a treasurer's report would have been handed out to those attending. Those who would like to see a copy of the report - please email me to request one.
- •Basically we had very little income this season as most dancers and clubs did not register with the R5CCDA or the BCS&RDF. The Williams Lake Stampede Whirlaways registered their club and their president. The R5CCDA registered its association and its executive members.
- •We cashed in the 3 long term deposits when they came due and deposited them in the general account. As previously announced, we transferred the R5CCDA account from Integris in Prince George to BMO in Williams Lake. At present, most of the R5CCDA executive members (including treasurer) all reside in Williams Lake so this will make financial operations easier. Further, BMO branches are more readily available in each city whereas Integris branches are not. This should make it simpler for new executive member changes in the future.
- •There were no Directors-at-large travel expenses this season and no Cariboo Connection expenses.

- There were monthly bank fees.
- The financial statement therefore shows a net loss of \$20.81 for the 20/21 season.

#### 5. Other New Business

#### **Region 5 Officers**

A. All of the executive officers have just completed their current 2 year term. (Yes, some of us have continued to work for the R5CCDA during this shutdown period.) All positions are now up for election.
President - Mary Anne Turner has completed her 8th year in this position.

Secretary - Nick Turner has completed his 8th year in this position. Vice-President - Sandi Jesperson has completed her 4th year in this position. Treasurer - Jordi Guri has completed his 2nd year in this position.

If all are in agreement, I would like to propose that the current executive members continue in their present positions until such time as the Covid situation is resolved and the dancing community in our region becomes active again. I would ask that the executive members contact me re: your willingness to continue. I also ask for any comments or objections from the other R5CCDA members. In addition, if there are members who would like to take on any of these volunteer positions, please let me know.

Their reasoning is that people who have been isolated for so long will be anxious to socially reconnect again and might see Square and Round dancing as a fun way to do that. However, they warn us that we should not be waiting to tell people about our recreation. We need to start now to make people aware of our existence and our benefits. We need to keep the idea of square and round dancing in front of people all year round, not just once a year.
